### DOUMENTATION

A timely reminder to all our partners

Please keep in mind that due to electronic manifesting, it is important that we receive all documents well in advance to avoid unnecessary fees and storage charges.

### Air Freight

Please ensure all pre alert documentation is forwarded to us no later than **24 hours** prior to aircraft arrival, as late documentation will incur a charge from Australian Customs for late manifest lodgement.

### Sea Freight

For all sea freight shipments please ensure all documentation is passed on to us as soon as possible as we **MUST** report the cargo to Australian Customs no later than **72 hours** prior to the vessel arrival to avoid any Custom delays in delivery of cargo.
