## General Travel Advisory—South Africa

#### 1. Don't Expect Wild Animals Wherever You Go

After all, South Africa boasts of the most amazing wildlife on Earth.

### 2. Don't Forget To Tip

Tipping is a part of the South African culture. One is expected to tip at least 10 percent of the bills amount at restaurants, cafes, as well as bars. Not doing so is considered impolite. Also, tips are expected for services like washing hair at salon and the like. This comes under the cultural do's and don'ts in South Africa.

#### 3. Don't Go Around Flaunting Your Valuable Items or Carry too much Cash

Be careful with precious jewelry and electronic items. Don't carry them around and flash them everywhere you go. If you rent a car, double check whether you locked it and don't leave your stuff and money unattended. Be sure to carry important documents with you at all times. South Africa is mostly a cashless economy & all the shops & stores accept all international & debit cards. The ATM facility is also available in most of the cities & gas stations.

### 4. Don't Stroll Around Without Knowing Where To Go

Don't roam around aimlessly in localities or cities; be aware of your location as well as destination. Steer clear of the bad neighborhoods which often lie very close to the good ones. Also, if by chance, you hear an angry mob or a demonstration, don't go towards it no matter how curious you are! Turn the other way.

#### 5. Don't Keep Your Valuables In Your Check-in Luggage

Don't put the valuable items like Camera, Cell phones, Jewelry, Cash etc. Keep all valuables in your hand luggage do not leave it in suitcases

#### 6. Don't Forget Your Plug Adapters

There might be a difference in socket board plug faces from your homeland so make sure you carry plug adapters for your electronic gadgets.

#### 7. Do get travel insurance

This is less about South Africa and more a tip for travelling anywhere in the world, no matter how 'safe' it seems. Comprehensive travel insurance is essential. Whether or not you end up using it, you'll be glad of the peace of mind it brings.

#### 8. Don't feed the animals

Be very careful at cape point where sometimes baboons become very aggressive when trying to take food

#### 9. Don't waste water

There have been water restrictions throughout South Africa in recent years, even if water seems plentiful when you are there please don't waste it.

#### 10. Don't use a taxi, take an UBER or BOLT

We recommend using UBER instead of cabs, which often don't have meters and may overcharge tourists. Solo female travelers need to be aware and never travel alone at night. If you're renting a car, get full insurance protection, keep nothing of value in the vehicle (or toss it in the trunk, if you must), avoid going off the beaten track, and be vigilant of speed demons. And remember, they drive on the left.



## Information on DG Shipments - ECU JORDAN



### **Good Day HCL Members / Management**

I would like to share the following regarding DG Air Shipments handling-operation & Registration formalities.... In Airfreight there are two types of agents as per IATA Regulations + should be as per your local authorities....

## Type1) None DG Handling Agent

## Type2) DG Handling Agent

- Type 1 > Two Employees must have CAT1 & CAT 3 DG Courses or CAT 3 For both (Including Airfreight Manager)
- Type 2 > Two Employees must have CAT 1 & CAT 6 DG Courses .(Including Airfreight Manager)

Type 1 > Considered as certified freight forwarder who authorized to quote and handle air shipments (General & Class commodities)

- Type 2 > Considered as certified freight forwarder who authorized to quote and handle air shipments (General; DG & Class commodities)
- Type 1 > Can handle DG shipments only if Import to own country. Can also handle cross trade DG shpts (if agent at origin is DG Handling agent); Export from own country prohibited.

Type 2 > Can handle DG shipments; Import & Export. For cross trade must still check if agent at origin is certified.

## Important Remarks Related to DG Handling Agent:

>>Each station office should check with civil aviation about the certified company who gives courses to attend.

>>The course passing mark is usually 80/100 despite of the CAT type

>>Only the Assigned staff at agent side can sign the shipper's declaration if client is not certified DG shipper >>The CAT Certificate valid for 2 Years...And must be re-new before expiry date

>>Some networks do issue shipper's declaration. Do not arrange the same from your office as there should be an official party at your country who is responsible to issue those certificates (Still have to be signed by your office).

>>Packing is shipper's responsibility however it is agent duty to check from inside and outside to assure compliance with DGR (Dangerous Goods Regulation)

>>Labeling and marking should be your responsibility to assure correct ones placed on packages and correct side as well.

## Information on DG Shipments - ECU JORDAN NORLDWIDE Important Remarks Related to DG Handling Agent: >>Transportation of DG cargo to airport must always be through dedicated trucking via a company aware of DG shipments. Avoid using consol / regular >>Must always check with carrier for acceptance prior of receiving cargo from supplier as not all airlines has service to requested destination neither may accept DG shipments (if restricted) >>You need always to assure that carriers have service to requested destination via PAX & CAO aircrafts. Not all airlines has freighter services. >>MSDS is not considered as official letter to export shipment more than giving agent an indication about commodity being accepted & same provided to airline for approval. However on time of moving / airing shipment; shipper's declaration must be issued at origin and accompany with cargo + copy to airline + attach original with shipment >> Your warehouse (if available) must have a particular area specially arranged to keep DG shipments (you can check locals about rules) Regardless having a warehouse or not; you have to have a warehouse for DG shipments >>Must have updated DGR booklet. Old ones not accepted neither valid. (Latest for 2020 is Edition 61) - You have to purchase yearly basis. IATA Provide electronic copy through internet but still you should have hard copy of the booklet available at your office. >>Whatever DG shipments you handle; arrange a file to keep for each separately from other cargos. This is not related to your internal system or policy of work; More than it is related to inspection you may have by officials at your own country visiting to assure complying with rules and regulations. 

#### **Coronavirus Intensifying and impacting Industry**



Lunar New Year this year is a difficult one, particularly in China. The outbreak of the Coronavirus is intensifying. This virus has spread to over 25 countries and the number is still continuing to increase.

This epidemic is causing supply chains to be severely impacted due to the factories being shut down. There will also be problems with shortage of man power, with many people placed under quarantine orders or leave of absence.

This Global Crisis is impacting Australia, several airlines in Australia are cancelling scheduled passenger and cargo flights due to limited or no bookings.

With China being one of the Major export countries all of this will cause a significant impact of the global economy. While the Chinese ports remain open with the exception of Wuhan, the shortage of man power is having a domino effect causing slowdown of loading /unloading goods.

For sea freight shipments out of China it is now being said that containers must be on the water for a minimum 14 day period once the vessel has left China before is arrives into Australia. This is causing delays to shipments.

Freight costs are also on the increase, due to the limited amount of staff working; trucking prices in China are also on the rise. In addition to this, many counties are refusing ships that have called into Chinese ports to enter into their own country until the crew aboard the vessels have been checked and cleared of the virus. Carriers have announced that they are reducing the number of vessels on routes connecting in China and Hong Kong with the rest of the world. These factors combined with shipment backlogs from the Lunar New Year will push the ocean freight rates and result in delays in shipments all around the world.
