Avvashya CCI Update to HCL Network Partners on COVID 19 Situation



Dear Valued Network Partner,

Please find our latest update on COVID 19 situation. As India strengthens her resolve and continues to fight the COVID-19 outbreak and impact, we, at Avvashya CCI (ACCI), are committed to doing our bit. In view of the social distancing directives issued by the central and state governments, **Our Teams throughout India remain operational to handle your nominations** with all the staff working remotely from the safety of their own home with adequate IT infrastructure to avoid any disruptions, within the prescribed norms. We have also implemented health and safety measures like masks, sanitizers and temperature checks at our respective facilities.

While we take necessary action to comply with increasing regulatory restrictions, be rest assured that our teams are working round-the-clock to support you. We are constantly monitoring the fluid environment and adjusting our approach to ensure we can continue to keep your cargo moving.

Considering the nation-wide lockdown which is now extended **until 03rd May 2020** however Factories in some states have started working from **20th April 2020** with very limited staff in comply with the guidelines issued by MHA (Ministry of Home affairs).

Port operations/vessel schedules

All Ports are operational except Hazira with certain restrictions although some delays expected on vessel operations due to shortage of operators, internal transport vehicles. With shortage of drivers and lock down of public transport, expect delay in port evacuation.

Some ports may have challenges managing the windows as for vessels coming from China, a 14-day quarantine is a must now (including transit).

We are abiding by all local regulations keeping in mind safety of our employee & partners and cargo.

Rail movement

Rail movement is not an issue so far as we see there are **no restrictions on freight trains**.

CFS/ICD/Yard operations

With public transportation being shut in cities, surveyors & laborers are facing difficulty in reaching site locations, CFS's will operational with skeletal staff.

1. With shortage of drivers and lock down of public transport, expect delay in CFS/ICD/Yard Operation Expect shortage of Labour for export stuffing/carting, We are engaging with local

authorities to issue passes for private vehicles / taxies in cities with restrictions meanwhile We have started intra-state & inter- state trucking for our cargo deliveries.

2. Port/CFS evacuation: Due to import container pendency at CFS's, CFS's are getting clogged with un-cleared containers, Please expect **delay in di-stuffed deliveries** (Mainly LCL Cargo) at Nhava-Sheva and Chennai CFS's. Avvashya CCI Update to HCL Network Partners on COVID 19 Situation



3. Shipping Lines are issuing fresh export bookings and empty containers yards are open with limited time period (10AM- 3PM).

Air Freight -

All the Incoming Commercial Passenger international Flights have been cancelled **effective 22nd March 2020 – 3rd May 2020.** However, this restriction will not be apply to international freighter operations and flights specifically approved by DGCA (Director General of Civil Aviation).

<u>Customs House Broker</u> – Indian customs are working 24x7 for essential cargo clearance although for general cargo clearance expect delays due to lock down of public transport, people facing difficulty in reaching site locations. Customers (AEO&DPD) who has permissions can clear without physical examination of cargo we have online solutions available.

Windlog Brings 6 Million Masks to Combat COVID-19



The Ukrainian cargo plane, model Antonov-124 considered the second largest aircraft in the world landed at Brasilia Airport in the early hours of April 7th, bringing 40 tons of masks for use against COVID-19.

In total, there are 6 million masks, where part of them will be donated to the Brazilian population, with

private distribution, without government intervention. The entire logistics operation was coordinated and carried out by Windlog headquarters in São Paulo.

According to Windlog's operational director, Gregório Gheorghiu, the greatest difficulty of this operation was the short time, in addition to the care taken with safety and prevention measures to avoid contamination of employees and the cargo.


"Since the material was originated in China, our team spent a few nights in clear, because of the time merger. In addition, the boarding and landing of a charter of this size involves several authorizations and necessary government certifications, something that Windlog is an expert. In all the coordination and management of this project, Windlog involved around 20 professionals and precisely because of this team we were able to carry out all the operation successfully and in record time". Gheorghiu Punctuates.

The last time the freighter landed at Brasilia was in September 2018, when the aircraft made a technical landing at the airport terminal to supply and rest the crew. The other appearance was in 2009.

The freighter Antonov has the capacity to carry up to 120 tons, is 69 meters long and just over 21 meters high.

After the masks were unloaded at the Brasilia airport, the material was sent to the State of Goiás by land. The giant plane leaved for Luanda, Angola, on Thursday (9/4) at dawn.

To add to this, our team also had to overcome multiple complexities posed by the customs procedures and door delivery during the Taiwan Lunar New Year Holiday, Kaohsiung sea tunnel height restrictions and the township road restrictions from POD Kaohsiung (southern Taiwan) to Taoyuan and Taichung.

We want to express our gratitude to the ECU Worldwide Marseille branch for their excellent support and cooperation. Despite the complexities and challenges, we successfully and safely completed the round-trip project shipment to Taiwan and back to France. And with this experience, we are ready to overcome the next challenge that comes our way.
