BLG International—Service



A special service that is widely requested during these days is that we can offer transit shipments via Frankfurt airport for neighboring EU countries.

Due to the actual airfreight restrictions, we do see increased inquiries from oversea agents and from agents from European neighboring countries to offer this kind of service.

If an overseas partner has an airfreight shipment to a neighboring European Union country and does not find any direct airfreight solution, we could arrange an import transfer from Frankfurt airport under transit document (T1) to the neighboring country. Some restrictions might apply, depending on the final country of destination, the final consignee and the value of the goods. Please send your respective requests to our FRA import team (<u>air-imp-fra@blg.de</u>) and they will check case by case, if a transit delivery would be possible.

Likewise, if an agent from a neighboring EU country has an airfreight shipment to overseas and does not find any direct airfreight solution, we could arrange an export transfer from Frankfurt airport under transit document (T1) to the overseas country. Since Frankfurt has more air freighter options these days then some of the neighboring countries do. Even if there is a direct solution from our neighboring country, we might get better airfreight rates ex FRA for huge shipments (+1000 kg). Therefore, please do not hesitate to contact our FRA export team (<u>air-exp-fra@blg.de</u>), if you have such inquiries.

Dear Agents,

Due to recent events there is ongoing berthing congestion at the Australian port

terminals. The congestion is causing vessels to be delayed through Sydney, Melbourne and Brisbane. As a result the shipping lines are adjusting port rotations to allow for the congestion, which ultimately is causing further delays.

Below are the contributing factors to the current vessel delays:

- Industrial action at the Stevedores
- Typhoon in Asia
- Bad weather conditions in Sydney
- Port congestion in Australian and countries around the world.

Coronavirus restrictions in different countries.

With the vessels facing berthing issues in Australia, this is further delaying their return voyage through South East Asia. Therefore shipping lines are adjusting their sailing schedules to omit ports in a bid to get back on schedule.

Important Notice - Sydney Port Congestion - Situation & Surcharges.

Please take note of the below urgent update regarding Sydney sea freight consignments. Due to a number of issues in Port Botany, including ongoing industrial action and critical overstock of empty containers, some carriers are imposing Sydney Congestion Surcharges on Imports & Exports at Port Botany, or omitting Port Botany and

This will have an impact on most FCL and LCL cargo IN & OUT of Sydney - The average Sydney Congestion Surcharge is USD 300/20ft, USD 600/40ft, and USD 15.00/CBM for LCL cargo - any surcharges charges shall be passed on at cost. Currently, MSC, ANL, CMA, TSL, Hapag, PIL & PAE have implemented these charges and we expect other carriers may follow suit in the coming days.

We are keeping an eye on the situation and will advise customers of impacted shipments.

Vessels Omitting Sydney:

Some carriers have stopped taking bookings to Sydney or are planning to omit Sydney on several of upcoming sailings in an effort to avoid the terminal delays further impacting their schedules. These omissions are seeing Sydney bound containers being discharged in other Australian ports with importers being left to make on forwarding arrangements by road or rail.

AIRFREIGHT MARKET NEWS

Air cargo volume out of China through August — deep in the industry's traditional slack season — has continued to improve, driven by a rise in demand for e-commerce products from consumers.

While the volume of air cargo exports from China was 17 percent down on the same month last year, that was a major improvement on the lows of April when the tonnage was down 41 percent. However, the supply-demand imbalance is keeping rates at elevated levels, sending airfreight prices soaring at the end of August.

In Europe, the market is experiencing decreased demand for the holiday season, with the trans-atlantic westbound market stable and decent capacity availability in and out of Asia. The outlier is the Frankfurt-to-U.S. corridor, where rates increased.

Air cargo operators are bullish about the remainder of 2020 because manufacturing continues to increase worldwide, online shopping is extremely strong, retailers are building up inventory in the fall for the holidays and tech giants are poised for major product launches this fall. Apple anticipates selling about 65 million to 75 million iPhones globally in the fourth quarter despite the impact of COVID-19, with Samsung likely to sell a similar amount of its latest device.

Lastly, there is quite a lot of action about preparation for the as-of-yet elusive COVID-19 vaccine cargoes. From our perspective, the feedback has been that airlines are largely booked out for Q4.

RAIL FREIGHT Rail freight companies continue to invest and reduce costs for customers. For instance, they have increased the payloads they can carry, with tonnage per train up by 80% in the last decade. When shipping by rail, the lower interest costs for the tied-up capital partly cover the higher transportation costs, making rail freight a very costefficient shipping alternative. As far as we already know of, COVID-19 had a mixed impact on the global rail freight market as regions line North and South America saw a decline in the rail freight market while Asia and Europe saw a rise in the rail freight traffic. Container traffic from China to Europe via rail grew 34% in the first half of this year, with a 72% rise year on year in June alone. In the long-term regional share of rail freight is expected to see a prominent increase. With this there is expected to be higher investment, further infrastructure development and technology implementation to digitize rail freight. The COVID-19 crisis has also resulted in the shortage of truck drivers, restriction on sea and air transport in many countries and regions. As a result, the cost of transportation through truck, sea, or air has sharply risen as compared to rail freight costs. This has made the shift to rail fright a supply chain advantage. 
