STAMP DUTY ON ELECTRONIC INVOICES FROM 2021

The Decree of the Ministry of Finance of 4 December 2020 definitively introduced for the year 2021 the stamp duty applied to electronic invoices pursuant to article 7-ter D.P.R. 633/1972

The cost of the stamp duty is EUR 2.00 for each invoice issued and is effective from 1 January 2021

The same amount will be charged on each invoice starting next April 1st 2021

DELAYS IN CARGO CLEARANCE IN GUARULHOS AND VIRACOPOS AIRPORTS COMPROMISE SERVICES AND FILL UP TERMINALS

TAKELOG

The two largest cargo airports in Brazil, Viracopos and Guarulhos, thermometers for the movement of air cargo in the country, registered significant increases at the beginning of 2021.

In January, Viracopos registered an increase in imports, reaching 36.8% in comparison with the same period last year, with a total of 10.9 thousand tons. Exports advanced 63.9% in January compared to the same month in 2020, with a total of 5.8 thousand tons of cargo.

Release delays - Although Guarulhos has not released its figures, the delays are at intolerable levels at the terminal. "We are monitoring all the times and we have reached a time of unacceptable deadlines for those who choose the air modal and, for this reason, want agility to remove their cargo", reveals Marcos Farneze, president of SINDASP.

Border Closure - the phenomenon of cargo growth that occurred in Guarulhos in February is attributed to the closure of borders around the world due to the pandemic. According to the press office, the flow of people is limited and there is no restriction on air cargo.

Cargo not located - Faced with insistent requests for emergency measures from some sectors alongside SINDASP, GRU Airport - Concessionaire that manages the Airport - has released emergency measures, which, however, have not yet had the desired effect. "Nothing changed. This delay already causes impacts, even reaching the point of not finding loads at the Terminals"

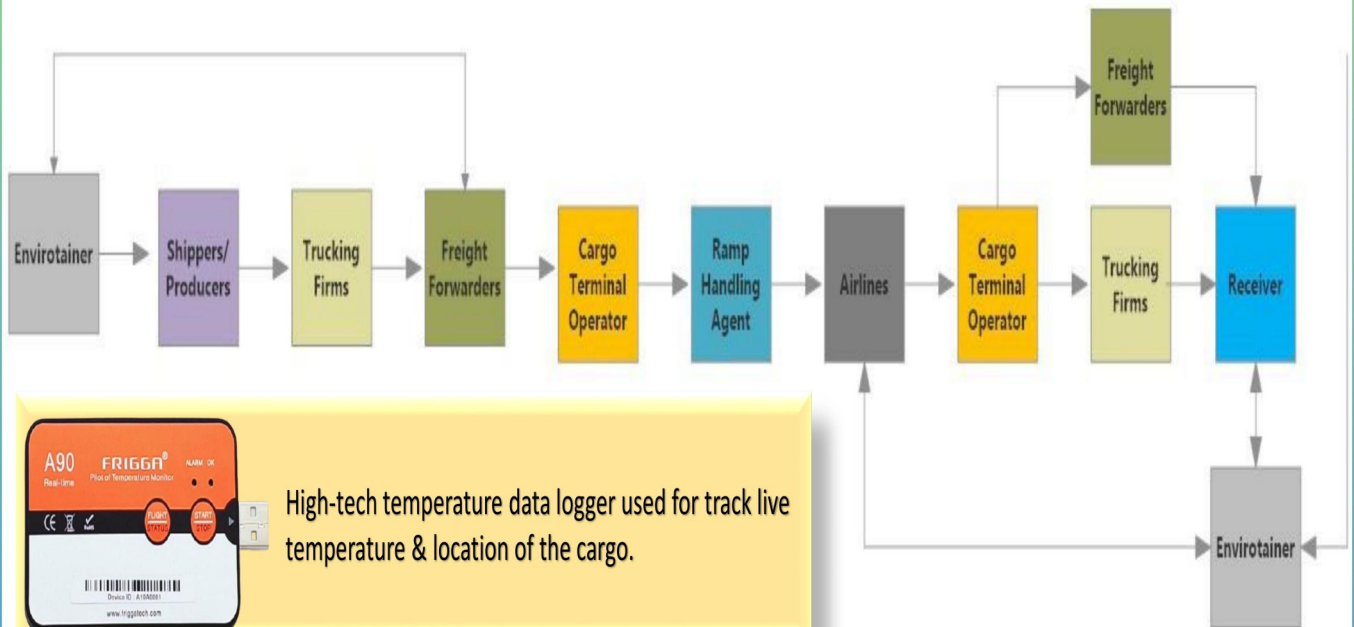

Suez Canal Blockage

March 26th, 2021

Large ship is preventing the transit of one of the world's busiest major sea lanes. **The ship 'Ever Given' was stranded in the Suez Canal due to technical failures.**

Since Tuesday (March 23), navigation of the sea route connecting the Red Sea to the Mediterranean has been **suspended** until the ship can be made to float.

In the absence of advances in the vessel's towing operation, the sector prepares for a prolonged closure, which can last for weeks. The blockade threatens to damage the supply chains of world trade.

"If the Suez Canal remains blocked for another 3 or 5 days, this will start to have very serious global ramifications", Niels Madsen, vice president of products and operations at Danish consultancy Sea-Intelligence, told Reuters news agency.

Global supply chains had already been hit hard by the coronavirus crisis. Now, the blockade of the Suez Canal, one of the main arteries of world shipping, may be a new problem for global trade, **including Brazil.**

Why might this become a problem with impacts on trade and the world economy?

- **The Suez Canal is a crucial link connecting East and West**, a 193-kilometer navigable canal located in Egypt that connects the Mediterranean Sea to the Red Sea.
- **The daily value of more than R\$ 50 billion is estimated.** The line of ships waiting to cross the channel includes more than 40 cargo ships carrying basic food from grains and cereals called "dry cargo", 24 tankers according to data from consulting firm Lloyd's List Intelligence, and approximately 88 ships carrying cattle and a tanker truck, according to Bloomberg.
- **Vital for supply chains.** The first problem can be found in port congestion, says Lars Jensen, an analyst at the Sea Intelligence consultancy.
- **Impact on prices for oil and other commodities.** According to EIA data, total oil flows through the Suez Canal and the SUMED pipeline (built in the Gulf of Suez itself) accounted for about 9 percent of total world oil traded by sea and 8 percent of liquefied natural gas.

The Windlog team is closely monitoring the status of the situation, and in frequent contact with ocean carriers regarding affected shipments.

Meanwhile, another factor set to boost regional multimodal connectivity is the Asean Customs Transit System.

The Asean transport ministries have approved up to five hundred trucks for cross-border permits. “The permit will allow goods to be transported across borders on the same truck from departure to destination point, thus eliminating the need to transfer goods to a local truck at a border” explained Mr Selmoni.



Furthermore, the ‘China plus one’ sourcing strategy – while not just the result of COVID – was likely to continue to facilitate increased road and multimodal volumes across South-east Asia. All Asean countries are impacted positively by the strategy as companies diversify their production bases beyond China, thereby driving intra-regional trade.

“This is especially nuanced in the key markets connected by an established road network – Singapore, Malaysia, Thailand, Vietnam, Cambodia and Myanmar –and increasingly extends further, to Indonesia and Laos, as well as to China.’
