Overview of the To Be Process

CNC will share required <u>SOA format</u> in which Netting participants will have to share their data (O/s AR+AP at invoice level). On receipt of the SOA from Netting participants, CNC will then upload these SOA a shared file folder where, <u>EPM</u> will automatically process the file & then Records will match with counter party books.NC will share required SOA format in which Netting participants will have to share their data (O/s AR+AP at invoice level). On receipt of the SOA from Netting participants, CNC will then upload these SOA a shared file folder where, EPM will automatically process the file & then Records will match with counter party books. Data would be processed as and when data file (SOA template) would be placed in the shared folder for initial upload and changes. Post processing, matching report will be shared We are currently planning to have 4 pre reporting and 1 final reporting to be executed during One ARCS Hyperion Netting cycle. The number of pre-cycles can be increased or decreased by CNC as and when required. Basis matching done in EPM system, Netting Participants will receive MATCHED, SUGGESTED MATCH and UNMATCHED report at invoice level during all the netting cycles (Pre & Final run) Basis Pre Reports shared by CNC, Netting Participant can perform their Follow-up with counter parties on their SUGGESTED MATCH and UNMATCHED transactions, They can add approved AP invoices in SOA template & follow-up with counter parties for their unapproved AR invoices as mentioned in unmatched report. For Next Pre-run or Final Run, Netting participants will have to share their Revised SOA template CNC and the same will be uploaded in Replace Mode for the participant's complete data. If CNC doesn't receive Revised version of your SOA then last received version in that month Netting will be considered for matching. On Final day of the run, Final Matched Transactions and Final Netting Settlement report will be shared by CNC via e-mail. Netting Participants will book manual netting vouchers in their ERP as being done earlier, based on the Final Netting Settlement report shared by CNC. Settlement should be done By" CNC as per amount mentioned in Settlement Report & Dates mentioned in Netting Calendar.

Ans: Yes, You can not use special characters like comma (,) & semi colon (;) anywhere is excel SOA template. Also you should not keep any single cell blank if you have use any invoice line. If there is no information to provide then you can use "NA"

Q3. What if the payable is not booked at all or payable is booked wrongly?

Ans: If any payable invoice is Approved but you have not mentioned in your initial SOA then you can add that invoice in your Revised SOA & share that with CNC in order to match that invoice in next Pre/Final Run. If you have booked any

Receivable or Payable invoice incorrectly then you need to correct that in your ERP system as well as in Revised SOA & share correct data with CNC in order to match those invoices in next Pre/Final Run

Q4. Will "Data Confidentiality" will be maintained during this Netting process?

Ans: Yes, 100% This Hyperion Netting Activity will be carried out by 3rd party vendor & Your Receivable & Payable data will not be shared within Network. In Pre & Final Reporting as well you will receive only those transactions data which is either in your books & in your counterparty books (which related to your office only) Hence Pls. be 100% assure about "Data Confidentiality"

Logistics plays including SF Express, Cainiao aim for skies with air cargo



Chinese logistics companies are beefing up efforts to invest in the air cargo segment and expand their global footprint as part of broader push to build logistics networks across the globe, improve delivery efficiency and ensure the stability and smooth operation of supply chains, experts said.

Ezhou Huahu Airport in Hubei province, which is backed by Chinese logistics service provider SF Express, recently launched its first all-cargo air route linking Ezhou with Shenzhen, Guangdong province.

As the first dedicated air freight airport in Asia and the fourth of its kind in the world, Ezhou Huahu Airport is expected to open over 50 domestic routes and 10 international cargo routes by 2025, with cargo throughput reaching 2.45 million metric tons. Wang Wei, chairman of SF Express, said the company will speed up the construction of Ezhou Huahu Airport and aims to build a world-class international air cargo hub.

The airport will open another all-cargo route from Ezhou to Shanghai soon, and is scheduled to add international routes connecting with Osaka, Japan and Frankfurt, Germany within this year. SF Express' freight transit center located at the airport is expected to begin operations in the second half of 2023.

Other logistics firms have invested heavily in providing air cargo services and building global logistics infrastructure. JD Logistics, an arm of Chinese e-commerce platform JD, has received approval from aviation authorities to put its self-owned air cargo fleet into operation.

The company said it will first develop domestic air cargo to cover major cities nationwide and accelerate its layout in international air cargo markets likes North America, Europe, the Middle East, Southeast Asia, Japan and South Korea by the end of 2025.

JD Logistics is stepping up efforts in the construction of logistics infrastructure globally. It has launched self-operated overseas warehouses in the United States, Germany, the Netherlands, France, the United Kingdom, Southeast Asia, the Middle East and Australia.

Yang Daqing, deputy director of research at the China Federation of Logistics and Purchasing, said currently, air cargo only occupies a relatively small portion of China's comprehensive transport system, which cannot meet consumers' fast-growing demand for high-tech products as well as cold chain logistics services covering the transport of fresh commodities and medicines.

Developing international air freight business will help enterprises boost long-haul freight capacity, establish overseas logistics networks and further improve cross-border delivery efficiency, Yang said. Cainiao Network, the logistics arm of Alibaba Group, has set up six smart logistics hubs around the world, operates more than 3 million square meters of cross-border logistics warehouses and has over 240 chartered flights for trunk logistics every month.

To reinforce its global logistics network, Cainiao has expanded the number of its overseas distribution centers to 12, with a focus on last mile deliveries and smart lockers to optimize and localize its services in destination countries.

Last month, the company announced it had launched its first smart distribution center in Brazil, and plans to launch another nine distribution centers in the country in the next three years.

"Overseas warehouses serve as vital infrastructure that boost growth in the nation's cross-border e-commerce sector," said Zhang Zhouping, a senior analyst of business-to-business and cross-border activities at the Internet Economy Institute, adding such facilities enable quicker Customs clearance, faster delivery and lower costs.







AEO Program: advantages for certified companies

The AEO Program (Authorized Economic Operator) certifies logistics chain operators as reliable for foreign trade operations.

So, to earn this certification and become a strategic partner of the Federal Revenue of Brazil (RFB), it is necessary to meet the requirements established by the program.

In this way, certified companies receive benefits and facilities in customs procedures, such as:

- Agility and predictability in foreign trade operations;
- Priority in cargo checking;
- Direct contact between the Brazilian Federal Revenue Service and the company;
- Cost reduction.

In addition, the Mutual Recognition Agreement between countries (MRA), which is bilateral, recognizes similar AEO certifications from Customs, from different countries, as equivalent to each other. As a result, cargo receives priority treatment, with fewer storage costs, to increase competitiveness.

Joining the OAS program is voluntary; until October 2022, 507 different CNPJs were certified, according to data from the RFB website. The OEA certification modalities are: OEA Safety (OEA-S) and OEA Conformity (OEA-C), levels 1 and 2.

Brazil and the United States signed a partnership between their OAS programs.
