

- Long distances: Another positive aspect is its ability to move cargo between continents, being the most commonly used for this purpose. It also transports goods between cities and countries, making it one of the best long-distance options.
- Bulky cargoes: The third advantage is related to the nature of the cargo. Ships can be adapted to carry bulky and heavy loads, which may not be feasible with other modes due to aircraft and truck limitations.
- Exclusive routes: Ships can reach places often inaccessible to other modes, ensuring a competitive advantage in the distribution or acquisition of goods.

#### Disadvantages of maritime transport

On the flip side, maritime transport also has disadvantages, requiring better planning from those involved in business. Understand these factors to evaluate if this is the most suitable mode for the company:

- Delivery time: The delivery time for goods traveling by sea is longer, as maritime transport is slower than other alternatives. In addition to slow speed, cargo handling and congestion are also decisive factors in the calculation.

#### Types of cargoes for maritime transport

We've discussed advantages and disadvantages, but evaluating the type of cargo is also crucial to finding the best solution to determining if maritime transport is the right choice. Cargoes are divided into four categories:

- Containerized cargoes: Containers emerged in the 1920s and revolutionized maritime cargo transport.
   This process involves container ships and stacking (containerization). It's the most common method because it accepts almost all types of goods.
- Bulk cargoes: Bulk cargoes are homogeneous, including solids, liquids, or gases. There is no unit counting in this type, and it's a form of freight without packaging, such as minerals, coal, and grains.
- Neo-bulk cargo: Unlike bulk cargo, neo-bulk cargo involves the formation of homogenous clusters of
  products. The volume allows transportation in batches during the same shipment. Examples include bales
  of cellulose, steel plates, and live animals. Specific types of ships are suitable for these categories, such as oil
  tankers and gas carriers.
- General break-bulk cargoes: The last category involves volumes packed in bags, bales, crates, drums, and other packaging or unpackaged items like vehicles, machinery, and blocks.

Data would be processed as and when data file (SOA template) would be placed in the shared folder for initial upload and changes. Post processing, matching report will be shared
